Congratulations on your participation in **RECon 2009 ICSC's** professional development sessions. To assist you with your efforts, The College of Southern Nevada (CSN) - Division of Workforce and Economic Development is pleased to offer non-credit Continuing Education Units (CEU's) for the professional development sessions you attended.

One CEU is defined as ten contact hours of participation in an organized educational experience. Coffee breaks, meals and social activities are not considered instructional hours.

CEU options are made available for **RECon 2009 ICSC** attendees as such:

The cost of one CEU is \$25. We will only issue CEU's in the following forms: 1 CEU (\$25), 1 ½ CEU's (\$38), 2 CEU's (\$50). There is also a one-time \$5 CSN registration fee for new students and a \$5 administration fee for processing and handling.

In order to receive the correct number of CEU's, initial the space under the "Verification of Attendance" heading on the report log to indicate which sessions you attended. CSN follows the honor system to verify session attendance. To preserve the integrity of the CEU program, participants are expected to claim only those hours spent in educational activities that have been approved for continuing education credit.

After the report log is completed, attach a copy of the CSN Non-Credit CEU Registration Form with your payment and mail or fax it to the college. Once we receive your CEU request packet, we will issue a certificate with the appropriate CEU's. It will be mailed to the address listed on the registration form within three weeks from date of receipt.
